2. Minutes -

5. Chairman's report –

Shared with everyone previous to meeting - those present thankful for receiving the documents prior to the meeting taking place, it allowed the meeting to flow. Dennis gave a brief overview/summary of his report (what did take place, didn't take place and reasons why...

6. Treasurer's Report –

Shared with everyone previous to meeting

Accounts remain healthy, end of year balance is £8651.37, showing a deficit of only £131.25 on the year.

Not only cash rich but stock rich too, some stock will need to be replenished as low on numbers of some sizes.

Affiliation fee for 2020 -21 was £0.00 due to Covid and no county competitions taking place.

Affiliation fee for 2021-22 to remain at £70.00

7. Motion – all present agreed with this motion

'That athletes from schools or colleges which do not affiliate, will not be eligible to participate in events organised by or on behalf of the county schools AA, nor represent the County in Inter County or English Schools Competitions; neither will athletes from schools or colleges which do not pay the contribution requested from them towards the cost of taking their athletes'

- 9. ESAA championships report previously shared within the chairman's report
 - a. X-Country no championships due to Covid
 - b. **Track and Field** took place but in a different form to previous years (one day per age group to minimise age groups mixing). Qualification different (see chairman's report)
 - c. **Combined events** Hosted by Bedfordshire & Luton at Bedford stadium a very successful championship and a huge well done to Dennis and his helpers for organising and allowing a smooth running of these championships. (see chairman's report)

14. Hosting of ESAA events – we are looking at hosting the following events (Allen raised that we have done too much over the years and maybe the ESAA are asking too much of us? However, the running of these championships has been done so well over the years under the leadership of Dennis is outstanding they keep coming back to Bedford - many note Bedford is a great venue for the events.

Final 17/18 Sept. Bedford

a) ESAA Schools T & F Cup Final Sat 2nd July 2022 Bedford (Friday afternoon Dennis may require help (GF/RE said they would if able to get out of school commitments) RE will provide kit carriers (2 teams of 8)

b) ESAA Combined Events Finals 17/18 September 2022 (help and volunteers required over the weekend - car park, general jobs on the day including some help with officiating (turning boards etc)

Dennis added after the meeting

'The amount of donations from ESAA for staging ESAA events is £8,500 over the past 12 years. The amount almost exactly matches the end of year surplus on 31 October 2021 (£8,651.37). Had we not staged any of these events, we would have needed to raise the affiliation fees to schools by a substantial amount."

15. ESAA proposals -

- a) <u>Walking events</u> no disqualification but to be put in a sin bin for 30 seconds (*all those present to support this proposal*)
- b) <u>Triple Jump</u> to take the Junior Boys event out of the championships/School cup (is this linked to injury or because girls currently do not triple jump at junior level? (*DJ to look at stats and to hear reasons why on the day of meeting*) Most in favour of keeping the event (unless data suggests it is too dangerous)
- c) <u>Mixed relay teams</u> to allow more teams to be entered at national schools level (DJ raised that female runners would need to be runner 1 and 2 due to possibility of injury) (*all those present to support this proposal*)

These proposals were not discussed at ESAA AGM as too little notice had been given to counties.

16. Impact of reorganisation of schools in Beds and Luton – No changes required at this stage

17. Succession planning -
